

CFWNC Recession Response Fund Grants – November 2009
71 Grants totaling \$437,555

Buncombe

ARC of Buncombe County - \$6,500 for the Direct Financial Assistance Program for people with Developmental/Intellectual Disabilities.

Big Ivy Community Development Club - \$2,500 for heating assistance to purchase wood and fuel that will serve approximately 50 families in the Big Ivy Community.

Bountiful Cities Project - \$7,600 for operating support, tools and supplies to further a number of community partnerships to develop urban community gardens.

Caring For Children - \$7,000 for Trinity Place, a transitional, short-term shelter for children referred by DSS, Juvenile Courts, mental health professionals, school personnel and from direct family requests.

Catholic Social Services Diocese of Charlotte - \$5,000 for Emergency Financial Assistance funds for food, utilities, rent and mortgage payments for families in Buncombe and surrounding counties impacted by the recession including immigrants who do not speak English.

Center for Participatory Change - \$15,500 to support a new VISTA program. VISTA members are full time, one-year volunteers who commit to a year of service in exchange for a living stipend, health coverage and an educational award. Eight VISTA's will be placed with organizations in five counties.

The Chapel Door - \$5,500 for the Lord's Acre which coordinates churches and volunteers to work in a community garden that provides local organic produce for families in need.

Children First of Buncombe County - \$7,000 for the Program Coordinator of the Family Resource Center at Emma

The Church of the Advocate - \$5,500 for direct emergency assistance to people who are homeless.

Grace Community Development Corporation - \$4,000 to provide low-income students with a nutritious meal and snack for the Success through Education and Prevention program.

Homeward Bound - \$8,000 for the A HOPE Center which serves the chronically homeless, those cycling through a period of homelessness, and individuals tenuously housed.

Irene Wortham Center - \$6,600 to supplement the increase in health insurance for the Supported Employee Program.

MANNA FoodBank - \$37,500 to fund an additional truck driver in order to enable increased deliveries of food supplies to agencies and begin making store level pickups primarily in Murphy, Sylva, and Waynesville.

Meals On Wheels of Buncombe County - \$7,000 to buy bulk quantities of food for preparation of individual meals.

Mountain Area Child and Family Center - \$5,000 to continue the Rainbow in My Pantry - Food Assistance Program that provides high quality nutritional food to low-income families through monthly food box deliveries and bi-monthly socials that teach food preparation and nutrition.

OnTrack Financial Education and Counseling - \$10,000 to hire a Tax Project Coordinator to prepare taxes, train and coordinate two volunteer tax preparers, and complete grant and IRS reporting.

Pisgah Legal Services - \$30,960 to provide legal aid across six counties for families in crisis due to the recession. There has been a 29% increase in cases in the past year.

Three Streams Family Health Care Center - \$5,000 for organizational and medical supplies for the regular operation of the adult primary care clinic.

Western Carolina Rescue Ministries - \$5,000 to increase their capacity to serve people in need of food and shelter due to the rise in unemployment.

Burke

Burke United Christian Ministries - \$7,000 to support crisis assistance for rent and utility payments to help people stay in their homes.

House of Refuge Ministries - \$5,000 to fund a fire alarm system, HVAC upgrades/repairs and concrete for Handicap accessible parking/walkway to enable a new homeless shelter to open.

Options, Inc. - \$5,000 to provide shelter services to women and children primarily in Burke County and surrounding counties as space is available.

Cherokee County Sharing Center - \$5,000 towards food supplies to enable clients to make two visits per month to this food pantry serving Cherokee County.

Hurlburt-Johnson Friendship House, Inc. - \$5,000 towards operating expenses of a homeless shelter in Murphy.

Murphy First Baptist Church - \$5,000 towards Sparrow's Nest expenses, a food pantry and crisis ministry serving Cherokee County.

Good Samaritan Clinic of Jackson County - \$5,000 towards costs of medications and related supplies for patients at this adult primary care free clinic in Sylva serving Jackson and Swain counties.

Mountain Youth Resources - \$5,000 towards operating expenses of the Hawthorn Heights Emergency Youth Shelter.

BLACK MOUNTAIN

Community High School - \$4,000 for Farm to Table: A Hunger and Employment Initiative. The grant will pay the supervisor of teen workers in this summer's garden program. Produce will be donated to families in need in the Swannanoa Valley through referrals from Swannanoa Valley Christian Ministry and The Welcome Table in Black Mountain.

Swannanoa Valley Christian Ministry - \$5,000 for the Crisis Utility (Power and Water) Fund, coupled with what the Ministry can supplement, approximately 25 additional families will benefit, enabling about 100 people – to include 35 youth and 10 elderly or disabled – to continue to have power and/or water in their homes.

Town of Black Mountain - \$1,000 for The Welcome Table to establish a food pantry. The Welcome Table is also extending its reach to those individuals in need of financial counseling, blood pressure testing and providing fresh produce from the Black Mountain Community Garden at the Community High School.

BUNCOMBE

Big Ivy Community Development Club - \$3,000 to complete the purchase and installation of two commercial size freezers and refrigerators to increase food storage capacity and access to better quality food such as dairy, meat and produce.

Catholic Social Services Diocese of Charlotte Western Regional Office - \$5,000 for Emergency Financial Assistance funds for food, utilities, rent and mortgage payments.

Children First of Buncombe County - \$5,000 for operating support to the Family Resource Center at Emma.

Helpmate - \$5,000 for operating support for the Crisis Stabilization Program for survivors of domestic violence.

Homeward Bound - \$5,000 for operating support for the A HOPE Center Homeless Project.

Jewish Community Center of Asheville, Inc - \$5,000 for operating support for the Employment and Career Coaching Service.

Burke United Christian Ministries - \$5,000 to support crisis assistance for rent and utility payments to help people stay in their homes.

The Outreach Center - \$5,000 to expand freezer capacity in order to increase distribution of nutritious food items through the federal TEFAP program.

CASHIERS

Hampton Preschool and Early Learning Center - \$5,000 toward its emergency tuition fund to assist families facing financial hardship with continuation of early child care.

Jackson County Department on Aging - \$5,000 to support the Cashiers Senior Nutrition Site.

Equipment will help increase capacity to reach target of producing at least 40 tons of vegetables contributing to more than 300,000 meals.

MCDOWELL

McDowell County Department. of Social Services - \$2,518 to continue the Community Garden Project.

McDowell County Schools - \$2,361 to provide food assistance to families in McDowell County in conjunction with the Family Resource Centers located in three elementary schools. Parents will also participate in a program called Circle of Parents to provide comprehensive, self-help services to families.

McDowell Mission Ministry - \$4990 to fund two commercial refrigeration units, for two different locations, to increase the capacity to accept more nutritious food items such as dairy, eggs and produce.

MITCHELL

Mitchell Community Health Partnership - \$5,000 for Food Distribution in partnership with Bakersville Baptist Church and Tipton Hill Methodist Church.

POLK

Thermal Belt Outreach Ministry - \$5,000 additional to purchase nutritious food for their Feed-A-Kid backpack program during the summer.

RUTHERFORD

Community Clinic of Rutherford County - \$2,510 toward a prescription voucher program that provides indigent patients with vital medications until they qualify for medical assistance programs through pharmaceutical companies.

The Salvation Army in Forest City - \$3,110 to support the distribution of food boxes to families affected by increased unemployment in the county.

Yokefellow Service Center - \$3,110 to provide emergency assistance for mortgage/rent, utilities, medications, clothing or food to families whose income has been reduced by layoffs during the past year.

BLACK MOUNTAIN

Black Mountain Pastoral Care and Counseling Center - \$2,500 for administrative and counseling support for clients unable to pay.

Hand in Hand of the Swannanoa Valley - \$2,500 for the all-volunteer program *Valley Churches helping Valley Students* that enables school teachers and counselors to address the critical financial needs of the students of the Swannanoa Valley.

Swannanoa Valley Christian Ministry - \$5,000 for the Crisis Mortgage and Rental Fund for clients experiencing imminent threat of eviction or foreclosure due to the recession.

Town of Black Mountain - \$2,500 to upgrade the kitchen facility with commercial grade equipment for the *Black Mountain Welcome Table*, expanding capacity from one lunch a week to possibly five lunches, one dinner and one breakfast.

BUNCOMBE

Big Ivy Community Club - \$5,000 for a commercial grade freezer to expand the capacity to distribute food in the Big Ivy Community.

Bountiful Cities Project - \$5,000 to support new neighborhood community gardens in low-income neighborhoods in Asheville.

Three Streams Family Health Care Center - \$5,000 to expand staff hours and provide 24 more patient appointments per week.

Western Carolina Rescue Ministries - \$5,000 to address the rising demand for food and shelter and to continue to offer job placement assistance for homeless men and women.

Western Carolinians for Criminal Justice - \$5,000 to expand case management services, particularly with food and employment, for 100 clients in the *Women at Risk* program.

BURKE

Burke United Christian Ministries - \$5,000 to support crisis services including the food pantry and soup kitchen and preventing homelessness by providing rental and utility assistance for people who are income qualified.

Good Samaritan Clinic, Inc. - Morganton - \$2,500 for general operating expenses including staffing, medical supplies and prescription drugs to provide quality medical care for uninsured families.

Outreach Center - \$5,000 toward food distribution by regional community food banks and job readiness assistance services in Burke County.

HAYWOOD

Bethel Rural Community Organization - \$1,350 for the *Benevolence Program* providing food and utility assistance to families through local community center.

Community Housing Coalition - \$5,000 for the urgent repair program to make critical repairs and provide safe housing for families in need.

Mars Hill Baptist Church - \$8,000 for the *Fields of Hope* community garden, which will grow produce for distribution by food pantries in Madison, Buncombe and Yancey counties and through MANNA FoodBank. Last year the community garden produced 21 tons of vegetables contributing to 168,000 meals. This year they are seeking to double the production.

Foothills Industries of McDowell County - \$2,000 for client transportation for employment and mental health services.

Grace Community Church - \$2,000 for emergency rent and utility assistance for families who have lost jobs due to the recession.

McDowell County Department of Social Services - \$5,000 for the *Food Pantry and Garden Initiative*. The DSS provides emergency food boxes for families who are waiting the five to seven days for food and nutrition benefits to begin. Additionally, able-bodied recipients of food assistance benefits are invited to work in the community garden to fulfill their federal guidelines on participation in work or education activities.

McDowell County Dread Disease Association - \$2,500 for medication assistance for families facing medical emergencies.

McDowell County Public Library - \$500 for unemployment and job search resources to meet increased demand from citizens seeking assistance in finding employment.

McDowell Mission Ministry - \$5,000 for utility and rent assistance for people applying for assistance for the first time due to layoffs.

Old Fort Crisis Ministries - \$3,000 to the Old Fort Recession Relief Fund for utility, rent and medication assistance for individuals and families facing crisis due to the recession.

MITCHELL

Mitchell County Health Partnership - \$5,000 to purchase food from MANNA FoodBank to stock food distribution centers established by the Mitchell County Health Partnership at the Bakersville Baptist Church and Tipton Hill Methodist Church.

Mountain BizWorks - \$50,000 for the *Small Business Recovery Project* serving Buncombe, Madison, Henderson, Polk, Transylvania, Haywood, Jackson, Clay, Cherokee, Macon, Swain and Graham counties.

Pisgah Legal Services - \$10,000 to help 40 families with children cope with financial and other crises exacerbated by the recession. Pisgah Legal serves Madison, Buncombe, Henderson, Transylvania, Polk, Rutherford and Yancey counties.

Service Center for Latinos - \$6,000 to provide emergency food, utility and medical assistance to families facing economic crisis in Mitchell and Yancey counties.

W.A.M.Y. Community Action - \$5,000 to provide garden vouchers and emergency assistance funds for families facing economic crisis in Mitchell and Yancey counties.

Western North Carolina AIDS Project - \$5,000 for emergency financial assistance to 33 AIDS patients who are working with case managers.
